By submitting this photograph, image, graphic, or artwork (collectively the "work"), you hereby agree to the following:

- You certify and warrant that you are the legal guardian of the minor who is submitting the artwork or are the artist and are legally an adult.
You certify and warrant that the work is your work or your child's own original creative work and does not violate or infringe the copyright or other proprietary or intellectual property rights of others.
You retain all copyright and equivalent rights but grant permission for the Solid Waste Special Service District #1 (d/b/a Canyonlands Solid Waste Authority) to use, reproduce, distribute, and/or release the work to the public in any manner and in any medium without payment of any fee, and in perpetuity.
To the best of your knowledge, the work does not contain any infringing, threatening, false, misleading, abusive, harassing, libelous, defamatory, vulgar, obscene, scandalous, inflammatory, pornographic or profane content.
To the best of your knowledge, the work does not contain any material that could constitute or encourage conduct which would be considered a criminal offense, give rise to civil liability, or otherwise violate any law.
If you break any copyright on your submitted work you agree to full responsibility regarding all royalties and fees owed to the person with whom you broke the copyright.
You acknowledge that the Solid Waste Special Service District #1 (d/b/a Canyonlands Solid Waste Authority) is not responsible for any artwork's misuse.
The Solid Waste Special Service District #1 (d/b/a Canyonlands Solid Waste Authority) works with professional, third-party vendors for leasing, printing, and hanging the artwork. In the unlikely event that the billboard is destroyed, torn, defaced, or damaged, the Solid Waste Special Service District #1 (d/b/a Canyonlands Solid Waste Authority) will make its best efforts to fix, replace or relocate the artwork. However, the Solid Waste Special Service District #1 (d/b/a Canyonlands Solid Waste Authority) is not liable if the work/billboard cannot be fixed.
The Solid Waste Special Service District #1 (d/b/a Canyonlands Solid Waste Authority) reserves the right to use contestants' names and works for educational publicity and/or promotional purposes, including website or exhibition of winning entries. You understand that works will be shared with reporters covering these awards and for promotion of the competition itself.
