Regular Administrative Control Board Meeting, 2023 Proposed Rate Increases for Electronic Waste, Locking Bar Service, 15-yard Containers, Wag Bag Rates, and Refrigerator Disposal

Solid Waste District, 19 June 2023 – PUBLIC NOTICE IS HEREBY GIVEN that the Administrative Control Board of the Solid Waste Special Service District #1 (District) will hold a Public Hearing beginning at 6:00 pm on Wednesday, July 19, 2023, during its Regular Board Meeting.

Consistent with provisions of the Utah Open and Public Meetings Act, Utah Code Ann. §54-2-207(4), this will be an Electronic Meeting with the Administrative Offices of the Solid Waste Special Service District#1 d/b/a "Canyonlands Solid Waste Authority" or "CSWA" as the Anchor Location. The purpose of the Public Hearing is to receive public input on the District's proposed 2023 rate increase for electronic waste collections, Wag Bag rates, rates for refrigerator disposal, locking bars services on containers, and 15-yard container fees. Rate changes are proposed to normalize, clarify, and adjust fee items that reflect the District's associated operating costs and support its enterprise fund. The purpose of the public hearing will be to hear comments regarding the aforementioned items.
